

Frank Luetz Driving Clinic & TREC for Drivers Clinic

Dates: June 20-22, 2014

Location: Hoosier Horse Park, Edinburg, IN

Entries for the Frank Luetz Clinic close: Thursday June 05, 2014 (there will be waiting list for the Frank Luetz lessons)

Frank Luetz Lessons:

\$130 per day includes one 45 minute individual lesson plus the group lesson at the end of the day: Friday – Group Cones Lesson, Saturday – Group Hazard Driving Lesson

\$110 for a 45 minute individual lesson Sunday, no group lesson included.

Your private lesson(s) can focus on dressage, cones, hazards or any combination

TREC for Driving Clinic: June 21-22, 2014

For our membership who would not be interested in participating in Driving Lessons. The club has paid for the park so we want to get as many members to enjoy it as possible, while offering learning opportunities and fun.

On Saturday we will walk and discuss the obstacles on foot before driving them. If your animal has not seen Obstacles like these you can hand walk them over first to take a look. Then we will have 4-6 turnouts practicing the hazards in Group Lessons.

The Obstacles are fun, but like anything else, they takes practice to execute with precision and TREC has outlines how the Obstacles are to be driven and Judged so this will be the goals of our practice. This is an "introductory clinic" to the new sport of TREC, not a formal introduction by professionals of the sport. Whether you drive a single, a pair or a multiple turnout, there is one \$40 fee. If you wanted to drive more than one single or pair, that would be \$40 first entry, \$20 second entry. You must be an IWWI member, or pay an additional weekend IWWI Membership fee for insurance purposes.

On Saturday, for Single turnouts **only**, we are not requiring you have a navigator - IF you are quite comfortable driving by yourself, but, at least one of the hazards requires a second person, "The Gate". **In TREC competitions "navigators are required"** as you will be going out into the countryside where the obstacle will be placed. For the Saturday Clinic obstacles will all be in an open field.

On Sunday we will have two fun Competitions 1) Driving the TREC Hazards,(maybe as a Gamblers Choice instead of TREC Rules as it requires an educated judge), and 2) a Timed Cones Competition (Both judged by ADS Pleasure Driving Rules & penalize breaks into canter) scheduled around the Frank Luetz Lessons. There also will be 1 or 2 Hazards marked for the Frank Luetz clinic. These Hazards, the Dressage Arena, and the Cones Course will be open for the TREC drivers to train in when not being used for lessons or games

Auditors: \$10 for one day, \$15 for two days, \$20 for three days (Frank Luetz only). One navigator or groom with the participant is free, two for a four-in-hand.

Auditing is FREE for driver and navigator participating in the TREC Clinic . There will be a speaker system for the Frank Luetz Clinic. Bring your own chair!

- Dressage Lessons will take place in a 40 X 80 meter grass arena.
- A Cones Course will be setup for Lessons
- One or Two Hazard(s) will be marked for lessons
- Helmets are required.
- Junior drivers 13yrs and under must have an adult in carriage.
- Payment with entry form will guarantee a spot. You will be notified by email as to your lesson(s) time with Frank.
- Cancellation of lessons with Frank by closing date, entry fees will be fully refunded. After closing, your entry fee will be refunded only if your spot is sold. Stall fee will be refunded either way. Cancellations for TREC are fully refundable if you cannot attend.

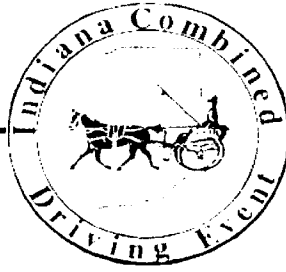
